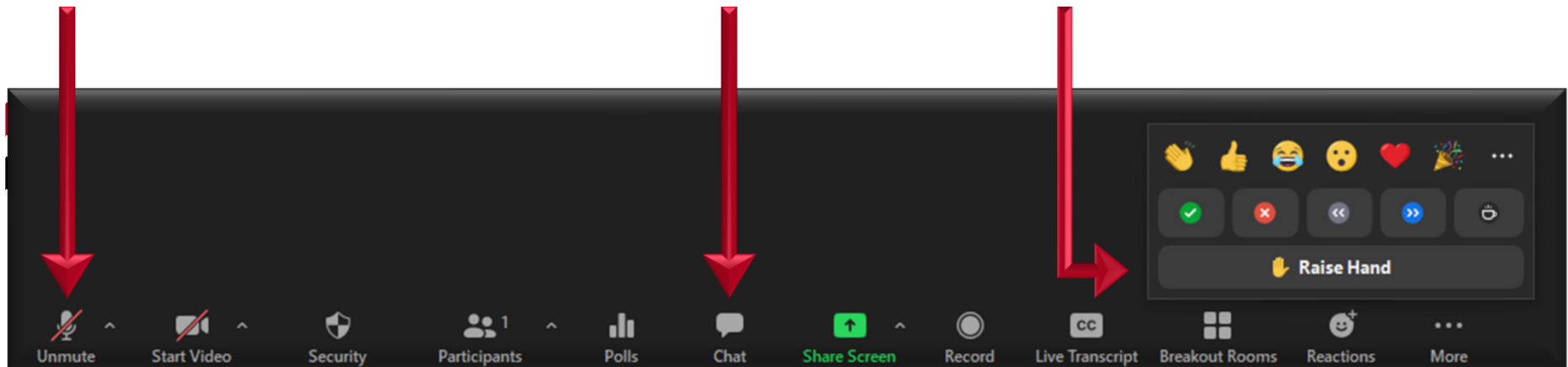

The Office strives to be a leader and thought partner in creating efficient processes that are designed in a way that supports student success and service excellence.



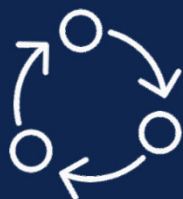

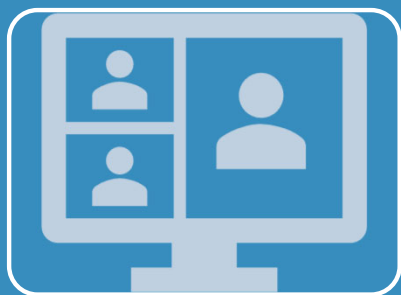
Can the University of Arizona explore getting rid of the 18 unit "W" grades limit for undergraduates? If it is not possible to get rid of this policy, would it be possible to allow students to do a complete withdrawal from summer session?

Can the Registrar and University explore the option of getting rid of the 60 UA unit limit on GROs? Instead, can all students just have a limit of 3 GROs in their UA undergraduate career? This would be a more accessible policy that would apply the rules equally to all UA students.

Will you please review the Retroactive Withdrawal process? We've had a couple students try for the retroactive withdrawal after failing courses - saying there was a reason they failed. I can read the steps on the website, but am more curious to learn from you about how many requests are approved? How does the college learn about the decision? What is the best way to advise students about the process?

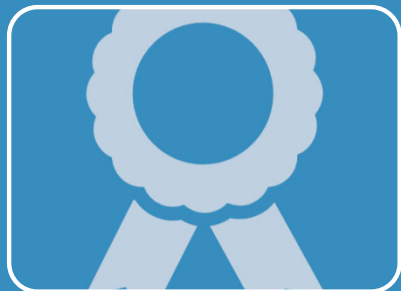


Survey Questions | Class Modality & Academic Honors



What is happening with the Live Online course modality? Are live online sections still being approved for Spring 2022 and future semesters?

Academic Distinction vs. Dean's List; if a student earns Academic Distinction, do they still earn the Dean's List? I'm trying to determine how best to recognize our students - and which students to recognize.
